- Join one of the board subcommittees (education, program, membership, finance, etc.)
- Attend Programs & Events as you are able
- Volunteer at Sunnyvale Art and Wine Festival First full weekend in June, minimum of a one-day commitment
- Attend & support Annual Celebrate Sunnyvale (late winter/early spring)

We ask that our Board members are visible in the community and introduce themselves as a member of the Sunnyvale Chamber of Commerce Board of Directors to other businesses and members whenever possible. We expect you to represent both your business and the Sunnyvale Chamber of Commerce values. We also ask that you invite other non-member businesses to join the Chamber of Commerce when the opportunity arises.

Although we do not endorse political candidates, occasionally the Chamber takes a position on ballot measures or local issues vetted by the business & policy committee and determined by the Board of Directors.
